

Bulgaria Adoption Expenses by Chronology

For Families in Florida, Georgia, Texas & Wyoming

The total cost of your Bulgaria adoption will consist of both CCAI Service Fees and expenses outside of CCAI Service Fees. One of the many benefits of CCAI's Bulgaria adoption program is that the costs are clearly defined from the moment you begin your adoption journey. The adoption fees and costs are spread out over the course of the entire adoption process. Expenses paid to CCAI throughout the adoption (highlighted in **BOLD** below) will be about one-fourth or less of the overall adoption expenses.

Below we have listed each expense necessary to complete your adoption in two trips, to whom it is paid, and when it is due. Each expense is identified by the **Key** and detailed in "Explanation of Non-CCAI Expenses".
